Course Description: RESEARCH/STUDIO DRWG 214

An introductory, studio based course emphasizing research and development of drawing practices through instructor initiated research and projects. Emphasis will be placed on the development of critical and conceptual skills and the acquisition of in depth knowledge of historical and contemporary drawing practice through instructor led readings and discussions.

Course Objectives:

The objective of the course is to assist the student in forming an understanding of how to combine Critical Thinking and Conceptual Development skills with personal artistic evolution. This is achieved by topic led student research informed through the execution of their artwork based on thematic course projects.

Group participation in critiques of the assigned projects sustains a constant feedback informing the students' conceptual progression and artistic growth through out the course. A class BLOG provides content relative to the project themes to aid the student research portion.



Upon successful completion of this course students will have:

- 1. been introduced to examples of contemporary drawing
- 2. gained an understanding of historical context relevant to the work studied
- 3. been introduced to contemporary art criticism in the analysis of contemporary drawing/art
- 4. developed skills in critical thinking, research and analysis of drawing/art

The objectives will be accomplished by the research and execution of theme based projects with various references from the historical to the contemporary.

Materials:

Execution:				

Is the work's execution relevant to the theme?

Is the composition pertinent to the student's theme explanation?

Theme Rational Explanation:

Does the concept explanation reveal work's illustrative intentions?

Does the articulation of process of execution reflect thematic concept?

Presentation:

Is the work's presentation in keeping with the rational?

Does the work's composition align with the presentation?

Projects/Assignments:

The student projects are to investigate and interpret various Drawing themes by creating a "body of work" that illustrates their personal interpretations on themes listed below.

The definition of "body of work" is artwork[s] that creatively illustrates the students' interpretation of the theme content.

Drawings and various media can be used in the execution of the artwork.

The student, using scale of presentation and intricacy of execution, will decide the exact amount of pieces for completion of each project as the criteria indicates.



Discussion with the instructor regarding the students' execution of the individual projects and the student's course progression is encouraged. Times will be assigned for individual meetings with the instructor through out the term.

These projects will be due every 1 to 2 weeks depending on the theme and subject to group critique.

Additional Expectations:

The student is expected to contribute to the learning environment by: sharing relevant information and participating fully in all class activities, critiques, and projects.

THINGS TO NOTE

When the studio door is closed do not enter.

Being late and having to set up while the crits are taking place is intrusive and disturbing to everyone in the studio.

You will be marked absent for the class, but will have the opportunity to present that week's project the following week.

Absences and missed Projects

The student who misses presenting a project on the class due day has only the following week to present the missed project with a grade point deduction of 10%.

Attendance and Class Participation:

Regular attendance is required. An attendance record below 50% will lead to an F grade.

Attendance at critiques is required; failure to attend will lead to an F grade.

Grading Process:

First Year Studies

- 1. First Year Studies students can use ACAD webService to access a statement of their mid-term grades.
- 2. Students are provided with feedback on their progress in the course at or before the mid-term of the semester so that the student may make an informed decision to continue or to withdraw from the course without failure.
- 3. Midterm grades do not appear on students' records and act as an indicator of students' progress in each of the classes in which they are enrolled.

School of Communication Design & Photography (Bachelor of Design)

- 1. In a professional design degree program, the number of projects within any given course creates a constant dialogue between instructor and student so that progression is clearly and constantly defined, therefore midterm marks are not given. Effective monitoring of students' progress throughout the semester is provided through the following activities:
- a. ongoing consultation with instructors;
- b. timely assessment of projects;
- c. comprehensive grading forms which are project-specific; and
- d. use of a warning letter distributed before mid-term and allowing students to withdraw without penalty. As another example of ongoing assessment of progress, faculty is encouraged to distribute warning letters whenever needed at any time during the semester.

Schools of Fine Arts and School Craft and Emerging Media (Bachelor of Fine Arts)

- 1. Students are provided with feedback on their progress in the course at or before the mid-term of the semester so that the student may make an informed decision to continue or to withdraw from the course without failure.
- 2. Students whose progress at mid-semester is not satisfactory will be informed by way of an official "Warning Letter" issued by the Registrar's Office.
- 3. The instructor may choose to request a "Warning Letter" be issued to a student who is failing to achieve course objectives at any time during the semester.
- 4. If it is not possible to accurately determine a letter grade by mid-term for certain classes, the instructor will provide feedback as indicated in 5(b) or 5(c).
- 5. Instructors teaching Fine Arts courses may choose to advise students of their progress in a course using any of the following methods:
- a. The instructor may post the grades of a class, providing that students in the class can only determine their own grade from the posting.
- b. The instructor may provide a written evaluation for each of the students in the course. The written evaluation will go only to the student being evaluated.
- c. The instructor may choose to meet individually with each student in the course in order to provide verbal feedback on the student's progression.



School of Critical and Creative Studies

- 1. A minimum of 30% of the grade will be given to the student by the 8^{th} week of class;
- 2. A minimum of 3 evaluative events is required, two of which will be written. These events include examinations, essays, case-reports and lab reports; and
- 3. No evaluative events can be worth more than 50% of the final grade.

College and Program Policies and Procedures:
